

Privacy Policy - tec-ease.com

Protecting your private information is our priority. This Statement of Privacy applies to www.tec-ease.com, and Tec-Ease, Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Tec-Ease, Inc. include www.tec-ease.com. The Tec-Ease, Inc. website is a information site and ecommerce site. Collection of your Personal Information
